TRUCK RENTALS & BEER LICENSES

Thank you for your reservation of a mobile draught unit. So we can confirm your reservation, please complete the following:

- 1. Alcoholic Beverage Control Regulations require that:
- A. Your event be held on the premise of a retail establishment which currently holds a Malt Beverage License, **OR**
- B You must obtain a Temporary License from the state by contacting:

WE RECOMMEND SECURING YOUR LICENSE 3-5 DAYS IN ADVANCE OF THE ACTUAL FIRST DAY OF YOUR EVENT IN ORDER TO RECEIVE BEER PRIOR TO THE EVENT. THE ABC LAW REQUIRES THAT YOU HAVE A VALID LICENSE TO PURCHASE AND RECEIVE BEER.

- 2. Complete the lower portion of this from and return it to Chas Seligman Dist, in the enclosed envelope with a check for \$150.00 per truck rental (this includes sales tax) made payable to: Northern Kentucky Beer Distributors Inc.
- 3. Please note that this fee is due on or before the delivery of the trailer. You will **not** receive the trailer until the fee has been paid.

A copy of your license must be posted on trailers at the event and MUST be faxed or mailed to Chas. Seligman <u>prior to delivery of trailer</u>. The license must be active on day of delivery.

It is hereby agreed that the rental of this equipment is for the purpose of storing and dispensing draught beers or selling cans or bottles of Chas. Seligman beer *ONLY!* No employee, volunteer or representative of the event or festival will have the authority or the capability to move any of the equipment once it is set in place. Any such required movement would be done by a Chas. Seligman Dist. employee or representative or have the express written consent of Chas. Seligman Dist. to do so.

It is agreed and understood the rental of this equipment holds the owner and/or rental agent harmless for any and all liability and renter agrees to reimburse the owner and/or rental agent for any damage or destruction to the equipment, including loss of any draught beer containers. The renter will not be held responsible for equipment failure not caused by the renter's negligence; i.e. compressor failure. **NO TAPE ON TRAILERS PLEASE unless approved by Chas Seligman.** There is a \$10.00 deposit for trailer keys. If the **keys are not returned when the trailer is picked up,** we will deduct \$10.00 from the event refund to replacement of the trailer keys.

It is understood that payment for the beer must be given to the driver at the time of delivery. According to Kentucky ABC law it is not legal to leave the unit unless payment is provided.
